



## Membership Categories

All VASA memberships are valid for 12 months (from April 1 to March 31 each year), include GST and are in Australian dollars. For new members joining part way through the membership term, the fee will be adjusted on a pro-rata basis.

### Service Centre - \$396

The business owner or at least one employee with a:

### National Wholesaler - \$1320

### State Wholesaler - \$495

Open to businesses wholesaling automotive electrical, engine cooling or air conditioning parts with branches in one state or territory only.



### Manufacturer - \$440

Open to manufacturers of auto electrical, air conditioning or engine cooling components or repair equipment.



### Corporate - \$132

Open to other businesses and entities with indirect involvement in the automotive air conditioning, electrical and cooling industry.








### Technician - \$99

A technician with a:

- Certificate III in Automotive Electrical, or
- Certificate II in Automotive (Mechanical-Radiator Repairs), or
- Certificate II in Air Conditioning, or
- National Refrigerant Handling licence, or
- Other qualifications approved by VASA.
